Terms and Conditions

- 1 Eligible One Central Rewards customers ("**Eligible Customers**") are eligible to participate in this offer from 1 December 2018 to 17 February 2019 (both days inclusive) ("**Offer Period**"). This offer is across One Central Macau, LANDMARK in Hong Kong and WF Central in the PRC. Eligible Customers are required to give consent to One Central Macau for transferring the customer's personal data overseas for the purposes of the activities under this offer in the prescribed consent form of One Central Macau . In addition, before 1 January 2019, in order to enjoy this offer, Eligible Customers are still required to join the LANDMARK Bespoke Programme and WF Central Rewards programme (as the case may be) unless the Eligible Customer is already a LANDMARK Bespoke Programme and WF Central Rewards programme customer.
